## Paul Mainuli, Director of Business Services

Mr. Mainuli's presentation of the First Quarter Financial Report for FY 19-20 focused on the overall expenditure and revenue picture of East Hartford Public Schools. Though the overall financial picture is sound, he did identify expenditure warnings that may carry through the fiscal year. The primary expenditure warnings identified by Mr. Mainuli, included the costs of Employee Health Benefits, Other Post-Employment benefits (OPEB), Special Education, Student Transportation and Magnet School tuitions. As a precaution, Mr. Mainuli recommended a budget freeze on expenditures for the remainder of the fiscal year. The Board agreed with his recommendation.
