- FY 2021-2022 Budget Process: Superintendent Quesnel briefly summarized the main cost drivers and mitigation strategies that were implemented to arrive at the final proposed budget allocation.
- Transition to Full District to Remote Learning Experience (RLE): November 30, 2020 through January 19, 2021, EHPS has canceled In-Person (IP) classes and shifted to a Remote Learning (RLE) schedule for all students, Pre-K through grade 12.
