# **EHPS End of Year Report 2021**

# Nathan Quesnel, Superintendent

The End of Year (EY) Report for East Hartford Public Schools (EHPS) serves as an accountability and narrative marker of the work of the district for School Year 2020-2021. The report included district highlights such as, ReOpen 4.0, Faculty and Student Vaccination programs, and the launch of EHPS' 5-year Strategic Plan- *Pride in 5*. Superintendent Quesnel also presented highlights from each division: Secondary Schools, Elementary Schools, Pupil Personnel Services, Human Resources, Operations and Finance and Technology. For a full listing of annual projects completed at the district and divisional level, please refer to the Mid-Year Report on the website.

#### American Rescue Plan (ARP) Update

Nathan Quesnel, Superintendent and Benjamin Whittaker, Chief Operations Officer Superintendent Quesnel and Mr. Whittaker provided an informative update to the BOE outlining the current utilization plan for the \$20,926,568 that has been allocated to EHPS by the Connecticut State Department of Education (CSDE) through the Federal American Rescue Plan Elementary and Secondary School Emergency Relief (ARP ESSER referenced herein as ARP) program. ARP funds provide an important avenue for EHPS to fully utilize significant federal funding to make a difference for students. Responding to the needs created by the pandemic of 2020, this planning integrates state and federal priorities with the EHPS strategic plan *Pride in 5*. As future funding and guidance is made available, this plan will continue to adapt to best meet district needs.

# Foodservice Program Wage Increase

#### Benjamin Whittaker, Chief Operations Officer

Mr. Whittaker reported that the EHPS Foodservice Program, managed by Sodexo, employs 82 hourly foodservice workers, of which 43% earn the current minimum wage or under the 8/1/21 minimum of \$13/hr. To increase stability and sustainability of the program and aid in current recruitment efforts, we have implemented a plan to bring the base rate for all hourly foodservice program workers to \$15/hour effective July 1, 2021. In addition, all other hourly employees currently earning more than the new base wage of \$15 will receive a \$1/hour wage increase to mitigate the effects of wage compression. This strategy will not have any impact to the BOE General Budget as EHPS Foodservice Program currently self-sustains from Federal funding and revenues generated by the program.
