Note: If similar questions were received by multiple parties, questions were combined to form one question representing intent and answered below. In most instances, questions retain wording verbatim, so grammatical and other errors are not on behalf of EHPS.

1. Is the District open to receiving partial responses for a portion of the requested services in the RFP?
 - i. EHPS is looking for one bus provider to meet all requirements listed in the RFP.

2. Regarding Request for Proposals Instructions, on page 2:
 - a. Please provide the anticipated award date.
 - i. EHPS looks forward to award in Q3 (January – March) of 2024.

 - b. Please provide the anticipated contract start date.
 - i. July 1, 2024

 - c. Please provide the anticipated date that the District expects buses to be delivered and for the yard to open.
 - i. Contractor is expected to provide all services by the start contract. EHPS does not own or control the existing bus yard.

 - d. May EHPS please provide additional details on the timeline between award -> contract negotiation -> contract start?
 - i. EHPS looks forward to start negotiation in Q2 (October – December) and award in Q3 (January – March) of 2024.

3. Regarding Indemnification and Insurance, on page 4:
 - a. Will the Board and Town of East Hartford consider a reasonable cap on damages?
 - i. EHPS will work with the awarded vendor to construct the resultant contract. All terms of the RFP will be applied to the contract.

 - b. Will the Board and Town of East Hartford consider a reasonable exclusion of consequential, incidental, indirect, or special damages?
 - i. EHPS will work with the awarded vendor to construct the resultant contract. All terms of the RFP will be applied to the contract.

- c. May the Board and Town of East Hartford agree that the indemnification obligations shall only apply to third-party claims, as opposed to direct claims from the Board or Town of East Hartford?
 - i. EHPS will work with the awarded vendor to construct the resultant contract. All terms of the RFP will be applied to the contract
 - d. May the Board and Town of East Hartford confirm that the attorneys and other professionals it engages on its own shall be at the Board and Town of East Hartford's cost, as the Awarded Bidder/Proposer will be covering the cost of their own attorneys and other professionals engaged to defend the Board and Town of East Hartford?

 - i. This information is not relevant to the RFP process, however it is accessible through the proper legal protocols.
 - c. Are drivers and monitors part of a union? If so, can the District provide a copy of the CBA?
 - i. EHPS does not control the labor arrangement/union status of the current transportation contract.
 - d. Is there a daily driver guarantee?
 - i. EHPS does not control the labor arrangement/union status of the current transportation contract.
 - e. May the District provide current hourly pay of drivers, bus aides/monitors?
 - i. EHPS does not control the labor arrangement/union status of the current transportation contract.

 - a. Will the District cover the cost associated with electricity? If so, what costs are eligible for the coverage or reimbursement? (Charging station, installation cost, construction, etc.,)
 - i. EHPS cannot answer any questions related to potential Electric Bus transition. Please reference the RFP for submittal requirements related to this potential transition.
 - b. Please provide the information on any available grants and trial programs in the District for electric buses, along with their availability date.
 - i. EHPS cannot answer any questions related to potential Electric Bus transition at this time. Please reference the RFP for submittal requirements related to this potential transition.
 - c. Does the contractor need to store the fuel on site? Or does EHPS allow for & reimburse the contractor for "wet hose" fueling that would be delivered onsite daily.
 - i. Contractor needs to store fuel on site or have alternate arrangements to store fuel provided by EHPS.
 - d. For the estimated 72 field trips and 312 athletics trips, is the contractor able to fulfill with route buses? Or is the contractor obligated to purchase additional buses to ensure 100% request coverage?
 - i. This is incumbent upon the contractor to resolve.
 - e. If so, how many additional buses?
 - i. N/A
 - f. Furthermore, can the Midday, late runs and work shuttles also still be done by daily route buses?
 - i. This is incumbent upon the contractor to resolve.
7. Regarding Other Considerations, on page 12
 - a. Will EHPS consider removing the Performance Bond requirement, or alternatively consider limiting the value of the Performance Bond to 1-year of the contract value? 100% of the contract value may be expensive for a 10-year contract.
 - i. EHPS has the OPTION to require Performance Bond per the RFP.
8. Regarding Appendix A - Pricing, on page 15:
 - a. What is the annual total mileage for the scope of this RFP?
 - i. EHPS has no knowledge of this information.
 - b. May the District provide average daily mileage for the daily recurring services outlined in Appendix A - Pricing?
 - i. EHPS has no knowledge of this information.
 - c. May the District provide detailed route sheets by bus type, including stops and times for the routes that are included in this RFP?

11. Please provide a copy of the current contract including the rates charged for the current school year.
 - i. This information is not relevant to the RFP process; however it is accessible through the proper legal protocols.

12. Please provide a 3-month sample of invoices that demonstrate how the rates are applied. It would be most helpful if those invoices were for months when the system was in normal operation (Non COVID).
 - i. This information is not relevant to the RFP process; however it is accessible through the proper legal protocols.

13. Because of the tiers, some buses being used for multiple routes, Appendix C does not give an accurate count of buses currently being used. Please provide a list of the current fleet being used to provide services including vehicle type and passenger size. This is also crucial information needed to provide accurate pricing for the RFP and a detailed plan for transitioning the fleet to zero-emission school busses by 7/1/2030.
 - i. The statement above is not entirely accurate. More detailed information may be disclosed upon request later in the negotiation process

14. What are the hours and miles billed; total cost for the year for extracurricular trips (Athletic and Field Trip)?
 - i. EHPS has no information related to mileage, or analysis related to hours/total cost for these activities.

15. Estimated Summer School transportation needs including number of routes and days operated.
 - i. Summer school varies significantly year to year based on programmatic needs and available funding sources. The last (5) years have all had a different slate of services and averaging would be accurate.

16. Did the School District pay the current contractor during the COVID-19 shutdowns (Spring 2020/SY 2020-21)?
 - i. EHPS paid all agreed upon invoices.

17. How are you paying the current contractor now for any partial days or non-operating days?
 - i. EHPS currently utilizes the same language reflected in the RFP under "Other Considerations" in terms of 180-day coverage.

18. What is your intent with payment going forward if a similar situation occurs during the term of the future contract? Would you guarantee a certain number of days or a percentage of payment to cover fixed costs?
 - i. Clear language regarding this subject is reflected in the RFP under “Other Considerations”
19. Has the district charged Liquidated Damages to the current vendor? How much annually?
 - i. No.
20. Is the current contractor short any drivers right now? If so, how many?
 - i. EHPS does not have this information
21. Will the district accept electronic (email) submission of the proposal?
 - i. No, all proposals have to be handed in at 12PM on October 27, 2023
22. The RFP does not mention any additional hard copies of the RFP. Does EHPS only want 1 hard copy of the proposal?
 - i. Only one hard copy is needed.
23. Does EHPS currently have any Electric buses in the fleet? If so, how many? What type of bus? Passenger count? Route type?
 - i. No, EHPS does not have any electric buses in the fleet.
24. Has EHPS applied for any grants for Electric buses? If so, what grant(s)? Have you been awarded any buses yet?
 - i. EHPS submitted a “concept paper” under the Federal *Renew America’s Schools* grant program for electric buses and infrastructure in early 2023, but was not selected to move forward in the process.
25. Does EHPS qualify for a lower commercial electricity rate as a school district?
 - i. Supply rates are currently contracted by the Town of East Hartford for School Facilities only.
26. Does EHPS pay the electric utility monthly bill directly? If not, who does the bill management?
 - i. EHPS currently does not directly pay for any electric usage and contractor-operated facilities.
27. Is EHPS open to a Charging as a Service (CaaS) model to support Electric buses? - CaaS aims to reduce the costs associated with establishing and maintaining EV charging infrastructure. By bundling hardware, software, installation, maintenance and support services into a single

monthly fee, charging station owners can avoid significant upfront investments and enjoy predictable, manageable expenses.

- i. EHPS cannot answer any questions related to potential Electric Bus transition at this time. Please reference the RFP for submittal requirements related to this potential transition.

28. What is the normal protocol for “blue sky” emergent early releases, is the provider of transportation required to accommodate emergencies or are parents responsible for emergency releases to pick up children? What is the typical emergency release frequency that you have experienced in the past?

- i. EHPS assesses these types of situations on a case-by-case basis.

29. Can you provide copies and tariff structures of the past 12 months of electricity use for analysis of load and additional load impacts?

- i. No, EHPS does not own or operate any facilities related to the bus operation.

30. Can you provide a copy of the current contract?

31. Can you tell me how long the current bus routes are or provide a list of the routes and times?

- i. The general route information was published in a local newspaper in August 2023, this information is located at the end of this addendum. Note that route information is subject to change.
